Emerging markets have special needs, and Atlantic Alcohol is well suited to flexibly collaborate with innovative systems and regulatory authorities.

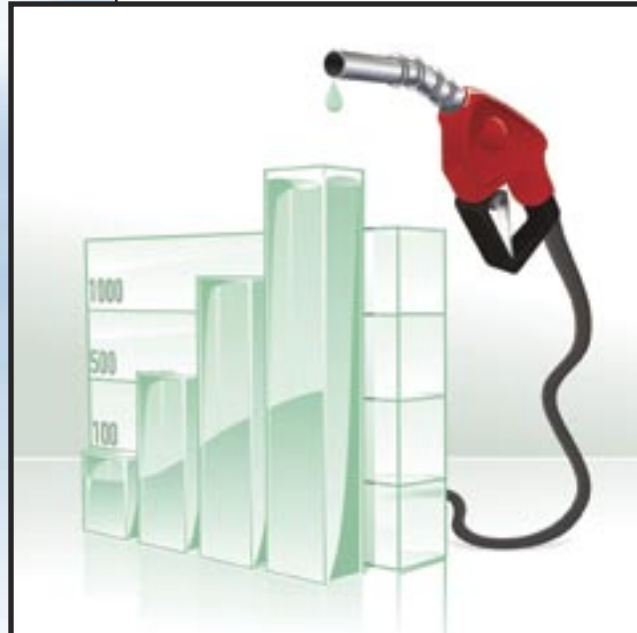

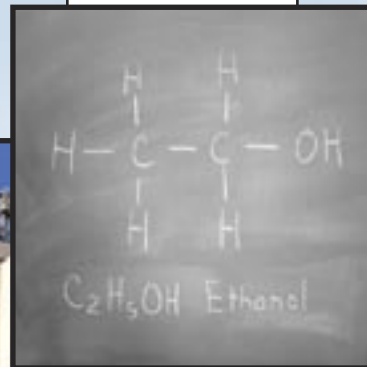
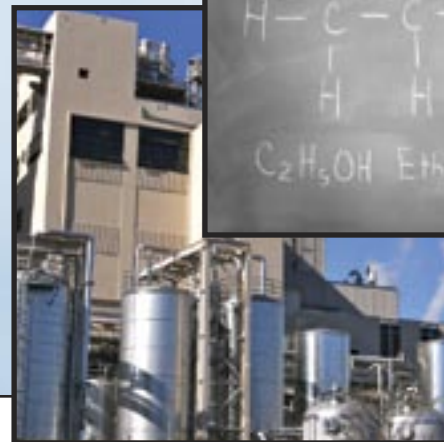
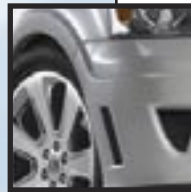
Our strong position as a dedicated line of supply provides the reliability required for both immediate and long-term delivery commitments.

## DESCRIPTION OF COMPANY

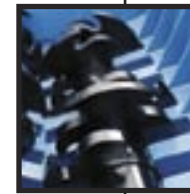
Atlantic Alcohol is organized in three divisions that each specialize in meeting the needs of significant stages in the supply chain.



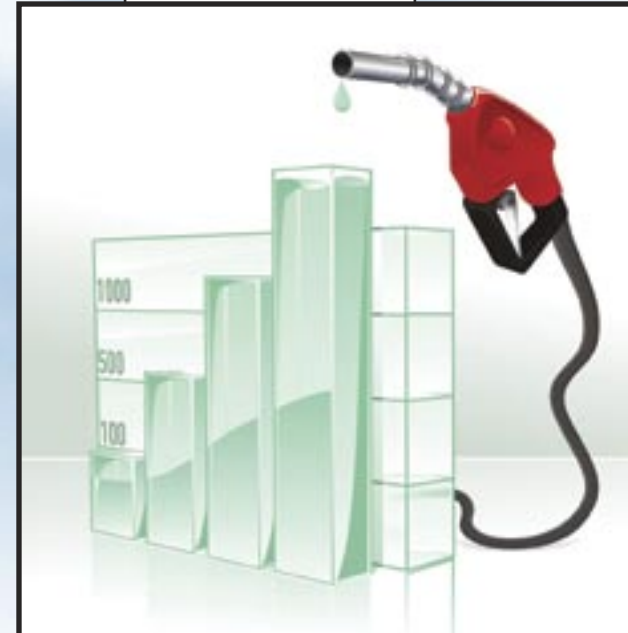
**ATLANTIC ALCOHOL, SUR AMERICA** administers production, initial processing, and supply within our producers co-operative. Our team offers supply redundancy in the source of product, and all product from members is sold through the COOP. Our family is growing! As we integrate members in our system, our capacity and redundancy increases. We are strong dedicated suppliers of ethanol and we will be able to meet increased volume needs into the future.



**ATLANTIC ALCOHOL, CARIBE** is responsible for storage, logistics and delivery of product throughout the Caribbean. Our footprint in the Dominican Republic (DR) and British West Indies, with strategic relationships throughout the Caribbean, matches our strong position as a dedicated line of supply with a strong position as a reliable partner for delivery and storage needs. Ethanol sales and distribution to Europe are also supported and facilitated by our DR team.



**ATLANTIC ALCOHOL, NORTH AMERICA** is responsible for storage, logistics and delivery of product to clients and partners in the United States and Canada. In addition to its strategic and management role for all operations, our principals maintain a lobbying presence with the Washington, DC regulatory community.
