Mohsen: I buy and sell cars...

Vahid : With who..?..

Mohsen: With babak..my brother..

Vahid : You and babak ?

Mohsen: Yes, we buy and sell cars...go to school sometimes.. as life goes on.. O.K....not like before that you were a bad influence....

Vahid : (Laughing)...I did that...?

Mohsen: When it comes to influencing...you are the master..., how is your business over there...?

Vahid : I know, it is not a problem.., for example, if you get in trouble and then I come over, would you put yourself in more trouble...?

Mohsen: I don't know what you mean....?

Vahid : Say, you are Abbas..Correct..? and you are already been hurt.. and the F.B.I. is after you... what would you do..? What would you do over there when I am already there and you do something against me?.. what is F.B.I. going to think...?

Mohsen: Well, may be it is not Abbas..and someone else..

Vahid : Abbas and/ or anybody else... ...For example, look at the O.J. Simson case... eventhough, Say.. O.J. had paid someone to that job for him, Abbas doesn't have that kind of money to defend himself, they wouldn't give him a trial, so he can spend 9 months or .. spend 16 months , he doesn't have that kind of money... What they do is.... immediately they cover it up... and put him in jail..and they tell him you were the cause of it...and you .. know how prejudice they are toward the Iranians..... For example, that Iranian boy, 19 years old, who killed that , 4 years old girl...truly he didn't kill her...she was found in his closet, or suitcase... dead.. 6 years old, or 4 years old... Then he was charged with rape and murrder...O.K. ...but, truly he didn't do that...but, to the present time , the court has proved...that he has done it...and they gave him life in prison and now they trying to execute him....

Mohsen: Did anyone turn him in..?

Vahid : No, see...they sent the body to England for an autopsy to see if there is any sperm of this guy in her body or not...

Mohsen: Excuse me a moment... let me turn this fan...it is getting hot in here..... Well, did they do the autopsy...?

Vahid : From legal point of veiw.....

Mohsen: How come they are so prejudice toward Iranians...

Vahid : That is the way they are...

Mohsen: Do you like it when they are this way...?

Vahid : No, I don't like them to be this way...

Mohsen: Then, you shouldn't be helping them ..if they are this way...

Vahid : I don't help them that way

Mohsen: How come they trusted you.. to do a job... if they don't trust Iranians...

Vahid : Well, ..because...I really don't know... may be because I didn't do any insurance..things..I don't want to answer this question now..on the phone...I am going to talk to you about it later.. and tell you what happened...how ..and why.. and how I got deeply involved...in this.....

But, ...over all ...I want you to stay out of it... don't even try to talk to Abbas...and if he calls, try to be cold..... because I don't want you to get involved in between... and get hurt... I am only telling you this for your sake...I truly like you...stay away... don't get ... involved....

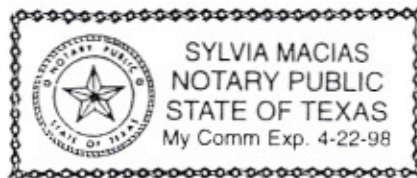
